- Received request from Lake Co. Equalization to authorize Lake Co. Equalization Director, Casey Guthrie as "Designated Assessor" as required by State of Michigan in the event a township assessor if found to be out of compliance after an AMAR Audit. L. - Jack Puff, SEEFDJBA read time line for construction of new Central Fire Station starting December 31, 2020 with construction starting about May 1, 2021. J. Puff then requested a loan from Elk Township in the amount of \$29,000 to start moving forward. Additional loan requests will be requested from Eden Township in the amount of \$9,700 and Sauble Township in the amount of \$11,300. Amounts are based
