- Luther Area Public Library has a Library Board position open and is asking for representation from Elk Township. There is no interest at this time
- Lake County Road commission discussed with L. Fitz that if we could provide \$27,000 in funds they would pay the balance to place 5-6" of 23A gravel on secondary roads. They suggested Mac Rd. from 8 mile to W. River Rd., River Rd. to Bass Lake Rd. and Toma Trail from River Rd. to Bass Lake Rd. It was suggested that we ask for 5" of gravel to include Toma Trail. B. Myers- motion to allocate \$27,000 from the Road Fund, D. Bass-seconded. Roll Call Vote: J. Hankiewicz, yes; B. Myers, yes; L. Fitz, yes; K. Fickies, yes; D. Bass, yes. Motion carried 5-0-0
- L. Fitz met with Peterson Well Drilling about an estimate to place 2 additional Hydrants at the hall, one across the driveway from the pavilion and one near the well head. The estimate is \$1,783.14. K. Fickiesmotion to approve estimate not to exceed \$1,800 from Building Ground Capital Outlay, J. Hankiewiczseconded. Roll Call Vote: D. Bass, yes; K. Fickies, yes; L. Fitz, yes; B. Myers, yes; J. Hankiewicz, yes. Motion carried 5-0-0
