Old Business:

- Lake County Road Commission L. Fitz received an extension on the December 1 deadline for the 2023 Road Projects until tonight. There are two road projects that did not get completed in 2022 due to lack of gravel. LCRC has sent new estimates on cost to complete these two road projects, (top dressing Toma Trail & 11 Mile from end of blacktop to Riverside Dr.) If these projects are to be done 2023, there would not be enough time to do additional projects. If we want to extend 11 Mile project from Riverside Dr. to Bear Track Campground, the cost would be the responsibility of the Township. Discussion to go ahead with both projects as estimated, LCRD will send estimate on cost of continuing work from Riverside Dr. to Bear Track Campground to be presented at the January meeting for action. L. Fitz-motion to contract with LCRC to do the 11 Mile Rd. project as indicated on the estimate sheet, dated 11/16/22, and Toma Trail from Bass Lake Rd. to River Rd. as indicated on the estimate sheet, dated 11/16/22, D. Bass-seconded, roll call vote, motion carried 5-0-0
- LCRC question on signage for Fire Station signs bill for \$510.84. Bill was for sign, posts and labor to install. Previously we only paid for sign, LCRC covered cost of posts and labor. LCRC has changed policy on "Specialty Sign". Supervisor gave check for \$510.84 to Leroy Williams to cover bill. Discussion about LCRC policy changes and communication with townships in advance. LCRC Commissioner Rick Haslock, committed to inform the townships of LCRC policy changes in the future.
- LCRC bill for Asphalt Aprons discussion. LCRC bill in the amount of \$41,645.48, we paid \$38,796.64 for a difference of \$2,848.84. Discussion about the cost, the patch on 8 Mile Rd. was included in the bill and Leroy Williams stated that anything above maintenance is the townships responsibility. The patch was requested to be done as it was a primary road and a driving hazard and dangerous. Request LCRC give us the total cost of the 8 Mile Rd. patch, Leroy Williams will call tomorrow with cost. We requested that LCRC communicate all changes to be done in writing. The Road Commissioners will discuss this issue at their next meeting and get back to us. No action taken at this time.
