• ARPA Funds, Reviewed the Project List. Update the Amount Expended on Marquee/Sign to \$3,495.00, discussion on board chairs, will check with Eden Township regarding their purchase of chairs.

New Business:

- L-4029 reviewed with new millage amount including the new amount for the Fire Station. Question regarding Headley Act, will need to ask L. Fitz before approving. B. Myers-motion to postpone action until September meeting, K. Fickies-seconded, motion carried 4-0-0
- ATT Metro Act Right of Way Permit Extension request through December 21, 2028. B. Myers-motion to authorize K. Fickies, clerk, to sign on behalf of Elk Township, D. Bass-seconded, motion carried 4-0-0
- Estimate from Johnson Construction for the damages to Hall during Attempted B&E in the amount of \$4,366.86.
 Quote sent to Insurance adjuster, received notification of approval and will receive check for \$3,866.86 (less \$500 deductible), K. Fickies will hold check until work is completed. K. Fickies reported sent email to Sheriff Martin regarding cost of damage repairs.
- Lake County Road Commission, LeRoy Williams presented Estimates for upcoming 2024 road projects. The combined project is for drainage, 23A road gravel River Rd. & Bass Lake Rd. to 11 Mile Rd., total costs \$246,144.44. This was broken down into 3 separate projects: River Rd. & Bass Lake Rd. to 10 Mile Rd. \$91,071: River Rd. from 10 Mile Rd. to Squaw Lake Rd. \$51,689.57: River Rd. from Squaw Lake Rd. to 11 Mile Rd. \$103,380.66. The LCRC will pay 50% of costs for the projects. We can choose to do the entire project all at once, or choose to break it into 3 separate projects over 3 years. Discussion regarding funds in Road Fund and upcoming income. R. Hasslock stated that if we broke it into 3 projects, cost may increase. LeRoy Williams stated he does not have to have a firm answer until December 2023 at the latest. K. Fickies-motion to postpone action until September or October meeting, B. Myers-seconded, motion carried 4-0-0
